Race Description

Optional 18 mile Iron/Beach change or 26 mile 9-man Changeout race on Lake Washington.
18 mile course is a loop from Sand Point Beach Park to a 1 1/2 mile buoy and back 5 times.
26 mile 9-man course is from Sand Point Beach Park around Mercer Island and back.

2. \$20.00 per paddler race fee

3. Escort boat fee: \$250 per crew (might be higher) - local crews are encouraged to get their own escorts. Escorts will be provided for out of state and far away clubs. E-mail boycf@comcast.net for escort boat reservations.

4. Race Rules is in accordance with PNW-ORCA and USACK. All paddlers must have a USACK insurance or sign a waiver and pay a \$10 event only race fee.

Crew Options

1. Iron - 6 paddlers only, irons the whole 18 mile race course. No escort boat needed.

9-man changeout - 9 paddlers changing out with an escort boat. COED/Mix Crews are close to even Male and Female up to 10 paddlers.

Beach Changeout has the same rules as 9-man crews but you can add up to 12 paddlers to do changeouts. No escort boat needed.

PACIFIC NORTHWEST OUTRIGGER CHALLENGE EVENT

WAIVER AND RELEASE OF LIABILITY READ BEFORE SIGNING

A. ADULT WAIVER AND RELEASE OF LIABILITY

IN CONSIDERATION of being permitted to participate in any way in the Pacific Northwest Outrigger Racing Canoe Association (PNW-ORCA) sports and recreation program and related activities ("Activities") I, for myself, my personal representatives, assigns, heirs, and next of kin:

1. ACKNOWLEDGE, agree, and represent that I understand the nature of Outrigger canoe racing (henceforth referred to as "paddling") and related Activities, and that I am qualified, in good health, in proper physical condition to participate in such Activity, and willingly agree to comply with the stated and customary terms and conditions of participation. I further agree and warrant that, if at any time I believe conditions to be unsafe, I will immediately notify the nearest official or my coach and discontinue further participation in the Activity.
2. FULLY UNDERSTAND that: (a) Paddling and related activities involve risks and dangers of damage to personal property and serious bodily injury, including permanent disability, paralysis, and death ("Risks"); (b) these Risks and dangers may be caused by my own actions or inactions, the actions or inactions of others participating in the Activity, the condition in which the Activity takes place, or the negligence of the "releasees" named below; (c) there may be other Risks and social and economic losses either not known to me or not readily foreseeable at this time; and I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES I incur as a result of my participation.
3. HEREBY RELEASE, DISCHARGE, AND COVENANT not to sue PNW-ORCA, the Kikaha O'Ke Kai, Sail Sand Point, or Tri-Cities Outrigger canoe clubs, their administrators, directors, agents, officers, members, volunteers, and employees, other participants, any sponsors, advertisers, and, if applicable, owners and lessors of premises on which the Activity takes place, (each considered one of the "RELEASEES" herein) from all liability, claims, demands, losses, injuries, damage to property, or other damages on my account caused or alleged to be caused in whole or in part by the negligence of the "releasees" or otherwise, including negligent rescue operations; and I further agree that if, despite this RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT I, or anyone on my behalf, makes a claim against any of the Releasees, I WILL INDEMNIFY, SAVE, AND HOLD HARMLESS EACH OF THE RELEASEES from any litigation expenses, attorney fees, loss, liability, damage, or cost which any may incur as the result of such claim.

B. ESCORT AND AUXILIARY ESCORT BOAT WAIVER

The undersigned do hereby expressly agree to indemnify and hold harmless the skipper(s) of our escort boat(s) against any and all claims, actions, causes of actions, damages and demands which may hereafter at any time be made, asserted brought or on our behalf arising out of or in any way incident to our participation in the use of said skippers(s), vessel(s) in the Pacific Northwest Outrigger Challenge.

C. AFFIRMATION

I HAVE READ THIS AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT AND HAVE SIGNED IT FREELY AND WITHOUT ANY INDUCEMENT OR ASSURANCE OF ANY NATURE AND INTEND IT TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW AND AGREE THAT IF ANY PORTION OF THIS AGREEMENT IS HELD TO BE INVALID THE BALANCE, NOTWITHSTANDING, SHALL CONTINUE IN FULL FORCE AND EFFECT.
